Minutes of the Town of Round Lake Regular Board Meeting October 11, 2018.

Present: Chairman Rolfe Hanson. Supervisors: Kay Wilson, Marilyn Karns, Sandra Schara, and Sharon Haak. Also Present: Clerk Kathy McCoy, Treasurer Vickie Palya, Fire Chief Schmidt, and 5 audience members.

Chairman Hanson called the meeting to order at 6:30 p.m. with the pledge of allegiance.

Clerk McCoy certified that meeting agenda had been posted as required on October 8, 2018

B.) Approval of Minutes; Regular Board Meeting September 13, 2018, and Special Meetings September 28, 2018, and October 8, 2018 (Two).

Motion by Karns to approve all minutes as printed: Second by Schara. Motion carried.

- A.) Audience Recognition Comments Only.

Request that Board members have name tags/ plates so they can be identified to audiences members. Need to fix town website – missing minutes past years – increase user friendliness.

B.) Monthly Recycling Card Drawing.

Rudy Seeger's name was drawn. He is awarded a free recycling punch card for use at the town recycling center.

C.) Conditional Use Application #18-020: Mathy Construction Co. Property Description: Part of the NW ¼ of the NE ¼; Part of the SW ¼ of the NE ¼; All in S2, T41N, R7W; Parcel #'s 024-741-02-1201, 024-741-02-1301; 56.46 Total Acres; Zoned Forestry One (F-1). Permit desired for the three (3) year renewal of conditional use permit #01-021 for the location of a non-metallic mineral extraction operation, including rock crusher. The CUP was originally approved at public hearing on March 20, 2001. Agent Candy Anderson – Milestone Materials.

Motion by Karns to approve Conditional Use Application #18-020: Second by Wilson. Motion carried.

- D.) Conditional Use Application # 18-018: Dale Mrotek. Property Description: The SW ¼ of the NW1/4 and the W ½ of the SW ¼ and that part of the E ½ of the SW ¼ lying West of State Hwy 77; S1, T41N, R8W; Parcel #'s 024-841-01-3301, 024-841-01-3201, 024-841-01-3403, 024-841-01-3101 and 024-841-01-2301; 154.44 Total Acres; Zoned Forestry One (F-1); Site address 12538 W State Hwy 77. Permit desired for the three (3) year renewal of conditional use permit #89-005 for the location of a non-metallic extraction operation, including rock crusher, and bituminous plant. The CUP was originally approved at public hearing on June 16, 1989. Agent: Candy Anderson Milestone Materials. Wilson brought forward discussion on making operating hours for all pits consistent within the Town. Mathy representatives explained that sometimes longer hours are needed to fulfill a contractual dead line. Motion by Wilson to approve Conditional Use Application #18-018 with the condition that crushing hours be 7a.m. -7p.m. Monday Saturday unless special demands warrant extension of hours to 9:00 p.m.: Second by Karns. Notice to enter into Public Contract required. Motion by Karns to run notice of intent to enter into public contract of more than 5,000 but not more than 25,000 as required: Second by Wilson. Motion carried.

I.) Allocation of 2017 Excess Fund Balance.

Motion by Haak to allocate funds as follows: \$4,529.87 to General Fund, \$30,000.00 to Bridge Reserve Account, and \$190,000.00 to Equipment Fund = Total 224,529.87: Second by Karns. Motion carried.

J.) Approve of proposed 2019 budget for publication.

Motion by Karns to approve proposed 2019 budget for publication: Second by Wilson. Motion carried. Budget Hearing will be held at 6:30 p.m. on November 8th, 2018.

K.) Fire Department Report: Schmidt. 1.) Written report on monthly activities. Written Monthly report provided (One Fire run on 9/16/18).
