## Minutes of the Town of Round Lake Board Meeting April 13, 2017

Present: Chairman Dave Sanders, Supervisors: Kay Wilson, Sandra Schara, and Marilyn Karns. Also Present: Clerk Kathy McCoy, Treasurer Vickie Palya, and 11 audience members.

Absent: Supervisor Rolfe Hanson

1.) Chairman Sanders called the meeting to order at 6:30 p.m. with the pledge of allegiance.

A.) Approval of Agenda.

Motion by Schara to approve agenda with name correction item 2. C William Turner: Second by Wilson. Motion carried.

B.) Certification of Meeting Posting

Clerk McCoy certified that meeting agenda had been posted as required on April 9, 2017.

C.) Approval of Minutes: Regular Board Meeting March 9, 2017.

Motion by Schara to approve minutes as printed: Second by Wilson. Motion carried.

2.) Items for Action, Discussion, Information:

A.)Audience Recognition – Comments Only.

Jim Onareheim spoke on creation of Sawyer County EMR (Emergency Medical Response) program. Mike Felder – Road Ban removal date – Weight restrictions were lifted Wed. April 12<sup>th</sup>. County Road S - Sanders indicated work should start in June - reconstruction / paving Teal River Bridge –Moose Lake Road.

B.) Monthly Recycling Card Drawing.

Warren Cook's name was drawn. He is awarded a free recycling punch card for use at the town recycling Center.

C.) Station One Remodel Plan update: William Turner.

Mr. Turner presented plans for a 34'x36' addition to Station One. Addition will have drain for vehicle washing and ice melt. Existing septic system can be used. Plan review date appointment with state 4/19/17 - (Cost of review \$400.00). Additions beyond expansion of structure will include replacement of old heating and lighting in existing building. Roof of existing building along with 2 exterior walls of siding will also need to be replaced. Turner suggested that the town hold one special meeting to open bids.

Audience member Cheryl Treland spoke to proposed changes along with additional changes the HAVCB would like to see.

Motion by Wilson that the town board recommends that the zoning committee / county board repeal existing ordinance and address the additional issues of the HAVCB and others through new ordinance. Second by Karns. Motion carried.

Motion by Wilson that position be filled by board appointment: Second by Schara. Motion carried.
