- 1.) Chairman Sanders called the meeting to order at 6:30 p.m. with the pledge of allegiance.
- A.) Approval of Agenda.

Motion by Strainis: second by Wilson. Motion carried.

B.) Certification of Meeting Posting:

Clerk McCoy certified that meeting agenda had been posted as required on May 5, 2013.

C.) Minutes Regular Board Meeting April 11, 2013.

Motion by Karns: second by Hanson to approve. Motion carried.

- B.) Bid Opening: Crack Sealing & Seal Coating,

C.) Land Use Plan Commission Report: Wilson – Proposed Sawyer County Zoning Amendments.

Chairperson Wilson gave update on meeting held April 24th. Written recommendations relative to Sawyer County Zoning Amendments were provided to board.

- D.) Proposed Sawyer County ordinance amendments:
 - Proposed change to Section 2.0 of Definitions (#49 Kennel) To correspond with Sawyer County Animal Control Ordinance. (LUPC) recommended approval.
 - Section 6.8 Kennel for Small Domestic Animals. To reference the entire Sawyer County Private Sewage System Ordinance. (LUPC) recommended approval.

Motion by Strainis: second by Karns to approve Section 2.3 Definitions #49 (Kennel) And Section 6.8 Kennel for Small Domestic Animals. Motion carried.

• Proposed change to Section 4.26 – Accessory Uses and Structures. To allow for garages to be built on property that lies across the town road from the dwelling provided certain criteria can be met. (LUPC) recommend denial of 4.26 (1) & Approval of 4.26 (2) C addition.

Motion by Hanson: second by Wilson to deny Section 4.26 (1) change. Motion carried. Motion by Karns: second by Strainis to approve Section 4.26 (2) C addition. Motion carried.

• Proposed additions to Section 6.23 Rules and Standards for Non-Metallic Mining. Include criteria for large scale mining/ or for frac sand mining. (LUPC) recommended approval of definitions. Had additional questions relative to 3) a) What are the large Pit Reclamation Plan guidelines? Who is the Department? And 3) c) Is the mitigation at the site or can it be elsewhere – No opinion due to these questions. Wilson had obtained guidelines from Sawyer County Zoning. Department confirmed that mitigation would be required on site. It was noted that Proposed additions were for Sections 6.23 and 6.24 of County Ordinance.

Motion by Karns: second by Wilson to approve Section 6.23 and 6.24 changes. Motion carried.

- Proposed changes to Section 17.0 Zone Districts. A.) Change due to state statutes that allow for in-home daycares for up to 8 children. B.) Language to allow for accessory structures/garages across the town road from the dwelling under "Uses Authorized by Conditional Use" in the R-1, RR-2, A-1, and A-2 zone districts.
- Proposal to add Funeral Homes under RR-1 and RR-2, and C-1 all authorized by Conditional Use. (LUPC) recommended approval.

Motion by Karns: second by Hanson to approve Section 17.0 Zone Districts amendments. Motion carried.

• Proposed change to Section 17.7 Industrial One Zone District (I-1) Add examples of industrial operations that would be permitted along with examples of activities authorized by Conditional Use. (LUPC recommended 17.7 – 1(A) approval. (17.7-1(B) 4.) – Strike chemicals, and other materials. 5.) Strike 6.) Strike 9.) Strike.

Motion by Karns: second by Hanson to approve Section 17.7 (I-1) Industrial One Zone District amendments contingent on the striking of items as recommended by Town Land Use Plan Commission. Motion carried.

E.) Final Approval Narvado Cell Tower Lease Agreement.

Motion by Wilson: second by Hanson to approve final lease agreement with correction to 25% ceiling limit for third party lessees on tower (change from \$4,800.00 to \$8,400.00). Motion carried.
