Review of activity at Spider Lake Board Meeting concerning ATV/UTV use on all Spider Lake  
Town Roads

Sharon Haak reported that the Town of Spider Lake postponed voting on a draft ordinance that would allow use of ATV/UTVs on all Spider Lake town roads. Instead the Town plans to survey its residents to garner public opinion prior to taking action. No timeline for the survey was announced at the meeting.

6. Sawyer County Recreation Map – Commission wants to include a map of Sawyer County showing recreational routes.

Carol Bacon reported that ten draft copies of the 2019 Comprehensive Plan will be ready for the August 28, 2019 Informational Meeting.
