Minutes of the Town of Round Lake Regular Board Meeting May 13, 2021

Present: Chairman Rolfe Hanson. Supervisors: Kay Wilson, Virginia Chabek, and Sharon Haak. Also Present: Clerk -Kathy McCoy, Treasurer - Vickie Palya, Fire Chief – Mike Schmidt, and 6 audience members in person, and an additional 5 plus audience members by WebEx.

- 1.) Chairman Hanson called the meeting to order at 6:30 p.m. with the pledge of allegiance.
- A) Certification of Meeting Posting.

Clerk McCoy certified that meeting agenda had been posted as required on May 9, 2021.

B.) Approval of Minutes; Regular Board Meeting April 8, 2021 and Special Board Meeting April 20, 2021.

Motion by Wilson to approve the minutes as printed: Second by Chabek. Motion Carried

- 2.) Items for Action, Discussion, Information:
- A.) Audience Recognition Comments Only. None
- B.) Monthly Recycling Card Drawing.

Brian Glover's name was drawn. He is awarded a free recycling punch card for use at the town recycling center.

- C.) Bid Opening: LRIP Supplemental Project "Twin Lake Road Bridge Replacement" Bids received: Stout Construction Total \$175,000.00. Larson Construction Total \$386,302.50. No action taken bids will be forwarded to project engineer for review.
- D.) McClaine Road Safety discussion and possible action.

Supervisor Chabek gave a presentation on possible ways to slow down traffic on McClaine Road. Residents living along the road have expressed safety concerns related to high speed of traffic; number of pedestrian's bicyclists / walkers/ runners, high volume of truck traffic, number of driveways, prior fatality. No action taken.

E. Plan Commission Report: Ann Berlage.

Berlage reported that the Commission recommended approval of Conditional Use Permits for:

- 1.) John & Tammy Wolf and Chad & Ann Lanette Franzozoi Application #21-012.
- 2.) Brain & Katherine Rieckenberg Application #20-008.
- 3.) James Sorboro (with condition of adding gutters and a drain system to help avoid any runoff issues) McClaine Road Safety Recommended traffic speed device and reducing McClaine Road speed limit to 45mph based on driveways within 100', number of pedestrians, bicyclists, and one (1) fatality in the past.
- F.) Conditional Use Application #21-012 John & Tammy Wolf and Chad & Lanette Franozoi: Property Description: Part of Government Lot 2, Lot 5 CSM 26,241 #8460; Parcel #024-741-30-5236; T41N, R07W; .79 Total Acres; Zoned Residential / Recreational One (RR-1). Permit desired for a 12'x 14' accessory building on vacant property, as per Sawyer County Zoning Ordinance Section 4.26 (1) the construction of a single accessory structure on vacant property may be allowed under this subsection by Conditional Use with mandatory conditions required on approval.

 Mr. Wolf explained request for accessory building temporary garden shed.

Motion by Wilson to approve Conditional Use Application #21-012 for a temporary garden shed: Second by Chabek. Motion carried.

G.) Conditional Use Application #21-010 James Sorboro; Property Description: Part of the SW 4/4 of the NE ¼, CSM 6/344 #1298: Parcel #024-741-20-1306; T41N, T07W; 1.99 Total Acres Zoned Residential/ Recreational One (RR-1). Permit desired for a 28'x 40'Accessory Building on vacant property, Sawyer County Ordinance section 4.26 (2) The construction of a single accessory structure on an adjacent parcel divided by a Public Roadway that does not contain the principal structure may be allowed under this subsection by Conditional Use.

Mr. Sorboro explained his request and had no objections to the Plan Commissions recommendation for gutters and drain system. One letter of objection received from adjacent property owner (Gilbert Family). One letter -no objection from resident along the road (Christina Cronkite). Motion to approve by Chabek with the following conditions;

- 1.) Condition of adding gutters and drainage system to avoid of any runoff issues.
- 2.) Exterior of the building be sided with dark board and bate siding similar to existing House exterior.
- 3.) Building to be located 64 feet from the center line of Clear Lake Drive (Doing this will create more of a buffer between the building and adjacent property owners pond). Second by Wilson. Motion carried.
- H.) Conditional Use Application #20-008 Brian & Katherine Rieckenberg: Property Description: The NE ¼ of the NE ¼ Part government Lot 1, Part Government Lot 2, Lot 4 CSM 34/220 #8161; SA33, T41N, R07W; Parcel #024-741-33-1103; Zoned Forestry One (F-1) and Residential/Recreational Tw (RR-2) Permit desired for: Island Development Section 4.4 (2) of the Sawyer County Shoreland Ordinance.

Mr. Rieckenberg explained request – small off grid structure – has mainland required lot access. Motion by Schara to approve Conditional use application #20-008: Second by Wilson. Motion carried.

 Motion carried.

Motion by Schara to approve license as stated: Second by Haak. Motion carried.
