BOARD MEETING REPORT -- Ann Berlage

Ann reported shared the CAFO ordinance with legal counsel advice and the importance of groundwater data collection. No real decision was made except to continue to gather info on groundwater. Ann also shared the Plan Commission's discussion about sharing info on the Dark Skies issue with the county.

STATUS: McClaine Road Safety

Ginny borrowed the speed gun in December to check if the speed changes are being followed. She was unable to collect enough data to have reliable data. Will try to get the speed gun during Birkie weekend and target the Twin Lakes Boat Landing and Bethel Road.

UPDATE & DISCUSSION: CAFO ORDINANCE DEVELOPMENT

- Ground and Surface Water Baseline Testing (Special Meeting January 6):
 - Identified an issue as the cost to owners. Sampling kits need to be readily available. Communicate with residents how we will collect data and why we are collecting. We need to stagger testing to allow the lab time to test them. May need to expand testing to include more metals i.e. manganese (manganese can cause developmental disabilities) Round Lake is the first Township in Sawyer County to request this type of testing. Will need to develop a 3-5 year plan for collecting data. Would want 1-2 samples from each square mile each year to help create a baseline for

data. More discussion to come. Will also be discussed at the next Town Board meeting.

 Proposed Draft Ordinance: The Town of Eureka has recently updated its proposed ordinance to be more thorough and complete - including more data and examples of damage caused by CAFOs. Push this forward to the town to make the recommendation to update our own proposed ordinance to include more information like what the Town of Eureka added to theirs. Ginny will take a first look at the document for making changes and bring it back to the Plan Commission next month.
