

Minutes of the Special Meeting Town of Round Lake Board of Supervisors August 2, 2022.

Members Present: Chairman Rolfe Hanson. Supervisors: Kay Wilson, Don Stover, and Virginia Chabek. Also Present: Clerk -Kathy McCoy and 2 Audience members.

1.) Chairman Hanson called the meeting to order at 6:00 p.m.

2.) Clerk McCoy certified that meeting had been posted as required.

3.) Approval of agent for Hillman's Callahan Corner LLC – agent Robert Perry Smith.

Motion by Wilson/ Stover to approve the appointment of Robert Perry Smith as agent for Hillman's Callahan Corner LLC: Motion carried.

Discussion/ review of Amendment to Ordinance 2022-04 (Town of Round Lake Non-Metallic Licensing Ordinance): Change minimum setback from 2000 to 3000 feet from the edge of the property boundary on which the mining operation is located to a residence. Board discussed County Non-Metallic Mining Ordinance and how current setback or proposed amended increased setback would affect the applicant. Also discussed - what additional protection/ buffer additional 1000 feet setback would afford residence.

7.) Approval of Resolution 02-2022: Referring Draft Amendment of Non- Metallic Mining Licensing Ordinance NO. 2022-04 to the Town of Round lake Plan Commission.


