Travis Butterfield CUP #22-026 – Recommendation to deny – finding of fact: It would not be consistent with the Town Comprehensive Plan; It would be significantly damaging to the rights of others and property values; It would create an air quality, water supply, or pollution problem. Commission continued work: High Capacity wells – request that Town Board draft letter to Sawyer County Zoning requesting that high-capacity wells be added to Section 17.71-1B, Uses Authorized by Conditional use, of the Industrial -1 zone district; Outdoor Recreational Plan and Update of Town of Round Lake Application Process Guide.

Applicant Travis Butterfield – change to reduce area to 10.37 acres zoned forestry one (1). Dust control by sprinkler system, spray bar on crusher. Audience member issues: loss of property values, truck traffic, dust, noise. Motion by Wilson to Deny Conditional Use Application #22-026 as stated for 39.85 total acres: Findings – Damaging to the rights of others and property values, create an air quality problem, not compatible with Town comprehensive Plan.
