## Minutes of the Town of Round Lake Regular Board Meeting December 8, 2022

Present in person: Chairman Rolfe Hanson and Supervisors, Don Stover, and Virginia Chabek. Also Present in person: Fire Chief Schmidt, Clerk - Kathy McCoy, Treasurer Vickie Palya, and (1 audience member – Travis Butterfield). Present virtually Supervisor Kay Wilson and 7 audience members

- 1.) Chairman Hanson called the meeting to order at 6:30 p.m. with the pledge of allegiance.
- A.) Certification of Meeting Posting. Clerk McCoy certified that meeting agenda had been posted as required on December 4, 2022.
- B.) Approval of Minutes: 2023 Budget Hearing and Special Meeting of the Electors November 10, 2022, and the Regular Town Board Meeting November 10, 2022. Motion by Stover/ Chabek to approve the October 13, 2022 minutes as printed.
- 2.) A.) Audience Recognition Comments Only. Martin Hanson Town Board development of policy for signage ATV/UTV use in the Town of Round Lake.
- B.) Monthly Recycling Card Drawing. John Clark's name was drawn. He is awarded a free recycling punch card for use at the town recycling center.
- C.) Land Use Plan Commission Report: Ann Berlage.

  Commission approved Travis Butterfield CUP #22-026 as amended based on the revised language and the conditions in the reclamation document of the amended CUP #22-026.

  Commission continued work: High Capacity wells, Outdoor recreational plan, Follow up ground and surface water baseline testing remediation wells high manganese levels, Potential signage ATV/UTV certain roads with high number of short term rental properties on them as renters do not know if road is approved for usage or not.

  Updated Town of Round Lake Application Process Guide completed and approved.
- D.) Action Item: Conditional Use Application #22-026: Travis Butterfield. Amended Property Description: Part of the NE ¼ of the SE ¼ S11, T41N, R08W; and Part of the NW ¼ of the SW ¼ S12, T41M, R08W; Lot 1 CSM 28-13#7170; Parcel #024-841-11-4101; Tax ID# 26555; Zoned Forestry One (F-1) & Residential/ Recreational One (RR-1); 39.85 total acres; Permit desired for the 10.57 acres of the Forestry One (F-1) zone district for the Location/ Operation of a non-metallic mineral extraction site. Permit desired for the 10.57 acres for the Sawyer County NR 35 Reclamation Issuance for location / operation of a non-metallic mineral open pit.
- Mr. Butterfield highlighted changes as per amended application: Pit size change from 39 10.7 acres entirely in F-1 Zone district. Crushing hours 8am to 5pm Monday Friday with crushing limited to 7 days total per year -Maximum pit size open at any time 5 acres. Supervisor Chabek provided board with 8 additional conditions relative to site operation. Motion by Stover/ Chabek to approve the Amended CUP Travis Butterfield #22-026 contingent on conditions of operation plan as presented and the following 8 additional provisions: Operator shall:

- The operator shall stake or otherwise mark the borders of the entire site and shall secure the site by appropriate methods.
- Operation of heavy vehicles entering or leaving the nonmetallic mining site or processing facility shall be limited to the normal hours of operation. Heavy vehicles shall not use "Jake Brakes" in the vicinity of the site so as not to create additional noise for adjacent landowners.
- Operator shall eliminate the use of lighting on the site outside of the normal hours of operations.
- The operator shall control off-site noise levels to the maximum extent practicable to avoid adverse impacts to neighboring landowners. The noise levels at the boundaries of the mining or processing site shall not exceed 60 db.
- Mining operations shall not extract materials at a depth below the point that is 10 feet above the groundwater table. Mining operations shall not cause an exceedance of groundwater quality standards in Wis. Admin. Code Ch. NR 140.
- Air quality shall be controlled using widely accepted methods sure as water application as required.
- All hazardous chemicals used at the site shall be stored and disposed of in accordance with applicable state and federal law.
- Loaders and other heavy equipment used within the site shall be equipped with "white noise" backup warning signals.

Supervisor Chabek requested roll call vote: Wilson – Yes: Stover – Yes: Chabek – Yes: Hanson – Yes: Strandlund absent. Motion carried.
