Minutes of the Town of Round Lake Regular Board Meeting June 8th, 2023

Commission continues to work on updating Element 6 of Town Comprehensive plan demographics with 2020 census information.

would provide year round access for ATVers to these systems (noted that ATV's are not allowed on 319 and trails off of it, during snowmobile season), General ATV Tourism Information , ATV Route Petition Town of Round Lake, supportive emails/correspondence. Cheryl Treland reviewed survey map done by Alliance of property owners along proposed route and responses received.
