Minutes of the Town of Round Lake Regular Board Meeting October 12, 2023

1.) Chairman Hanson called the meeting to order at 6:30 p.m. with the pledge of allegiance.

- 2.) Certification of Meeting Posting. Clerk McCoy certified that meeting agenda had been posted as required on October 9, 2023.

- 6.) Land Use Plan Commission Report: Ann Berlage. Ms. Berlage reported that commission lacked a quorum and did not meet as schedule October 12, 2023. Commission member Jane Bidwell will be resigning. Groundwater testing is done and results completed for 2023. Members continue to work on Outdoor Recreational Plan, TAP Grant, Round Lake neighborhood handout, looking into ATV/ UTV D.N.R. trail 8 grant and trailhead needs/ issues. Economic Development Plan Document is competed,
- 7.) Town Representative to attend Zoning Committee meeting October 20th, 2023 clarification and broader spectrum Sawyer County text amendment for Multi-Dwelling Development. Motion by Strandlund / Wilson that Don Stover attend meeting as Town Board Representative: Motion carried.
- 8.) Approval of Budget Resolution No. 04-2023: Allocation of Flex Grant funds carryover from 2022 to 2023 budget in the amount of \$15,966.00 Motion by Stover/ Strandlund to approve Budget Resolution 04-2023: Motion carried.
- 9.) Approval of Budget Resolution No. 05-2023: Trust Fund receipt of monies \$341,000.00. Fire Department Capital Outlay additional \$341,000.00. Motion by Wilson/ Strandlund to approve Budget Resolution 05-2023: Motion carried.
- 10.) Approval of proposed 2024 Town Budget for publication and posting. Confirmation of Date and time of 2024 budget hearing and special meeting of Town Electors. Motion by Wilson/ Stover to approve publication of 2024 proposed budget as printed and set budget hearing date (November 8th, 2023) Time (6:00 P.M.) Location (10625 N County Road A - Town Hall). Special meeting of electors to follow budget hearing. Motion carried.

Presentation and final -Town of Round Lake EOP (Emergency Operations Plan) Mike Feldner Round Lake Fire Department presented final EOP to board members emphasizing that plan is a living document that should be reviewed and updated as needed throughout the year with an annual total review/ update in January of each year. All board members have copy of plan as do both fire stations, town office and garage.
