## Select Survey Highlights

- A total of 1,381 surveys were distributed to property owners in the Town of Round Lake.
- 274 surveys were returned (an exact response rate to the survey is not known because recipients could make copies of the survey for other adult household members and renters were able to complete a survey by picking up a survey at the Sawyer County UW-Extension office).
- 46.9% of respondents are Town residents (127) and 53.1% of respondents are seasonal residents (144).
- 67% of responses are male (179) and 33% are female (88).
- 7.7% of responses (21) are 44 years of age and younger, 54.6% of responses (148) are between the age of 45-64, and 37.6% or responses (102) are 65 years of age and older.
- 8.1% (22) strongly agree or agree on expanding mobile home parks while 77.6% (212) strongly agree or agree on expanding senior housing.
- 98% of respondents report the level of importance of town roads to be very important or important.
- 90.9% (240) of respondents report the level of satisfaction of town roads as very satisfied or satisfied.
- 61.6% (167) of the respondents found the adequacy of County land use policies as adequate/very adequate. 20% found the policies to be very inadequate and 18.5% had no opinion.
- 59.5% (160) of the respondents found the adequacy of County land use regulations as very adequate or adequate, 21.9% (59) as inadequate or very inadequate, and 18.2% (50) with no opinion.
- 72.0% (196) strongly agree or agree, 25% (68) disagree or strongly disagree, and 2.9% (8) had no opinion when polled if steps should be taken to reduce forest fragmentation.
- 62.4% (169) strongly agree or agree, 26.9% (73) disagree or strongly disagree, and 10.7% (29) had no opinion when polled if steps should be taken to reduce farmland fragmentation.
- If wind turbines should be allowed to be constructed within view from lakes and shorelands found 37.9% (102) strongly agree or agree, 55.1% (148) disagree or strongly disagree, and 7.1% (19) had no opinion.

•	When indicating their level of agreement regarding where new housing should be located, "Anywhere there is suitable site for development" found 25.7% (68) strongly agree or agree, 64.5% (171) disagree or strongly disagree, and 9.8% (26) had no opinion.
